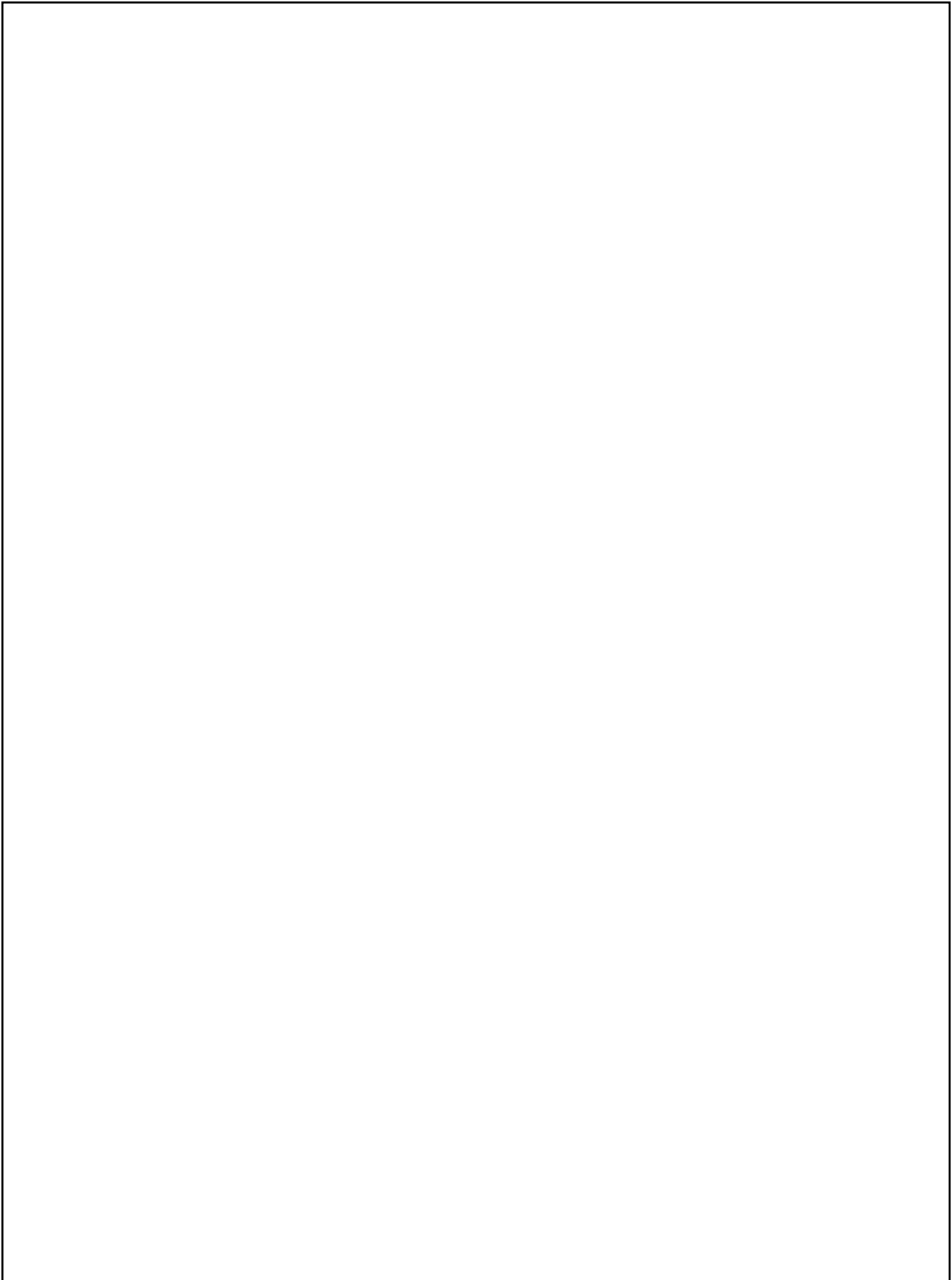

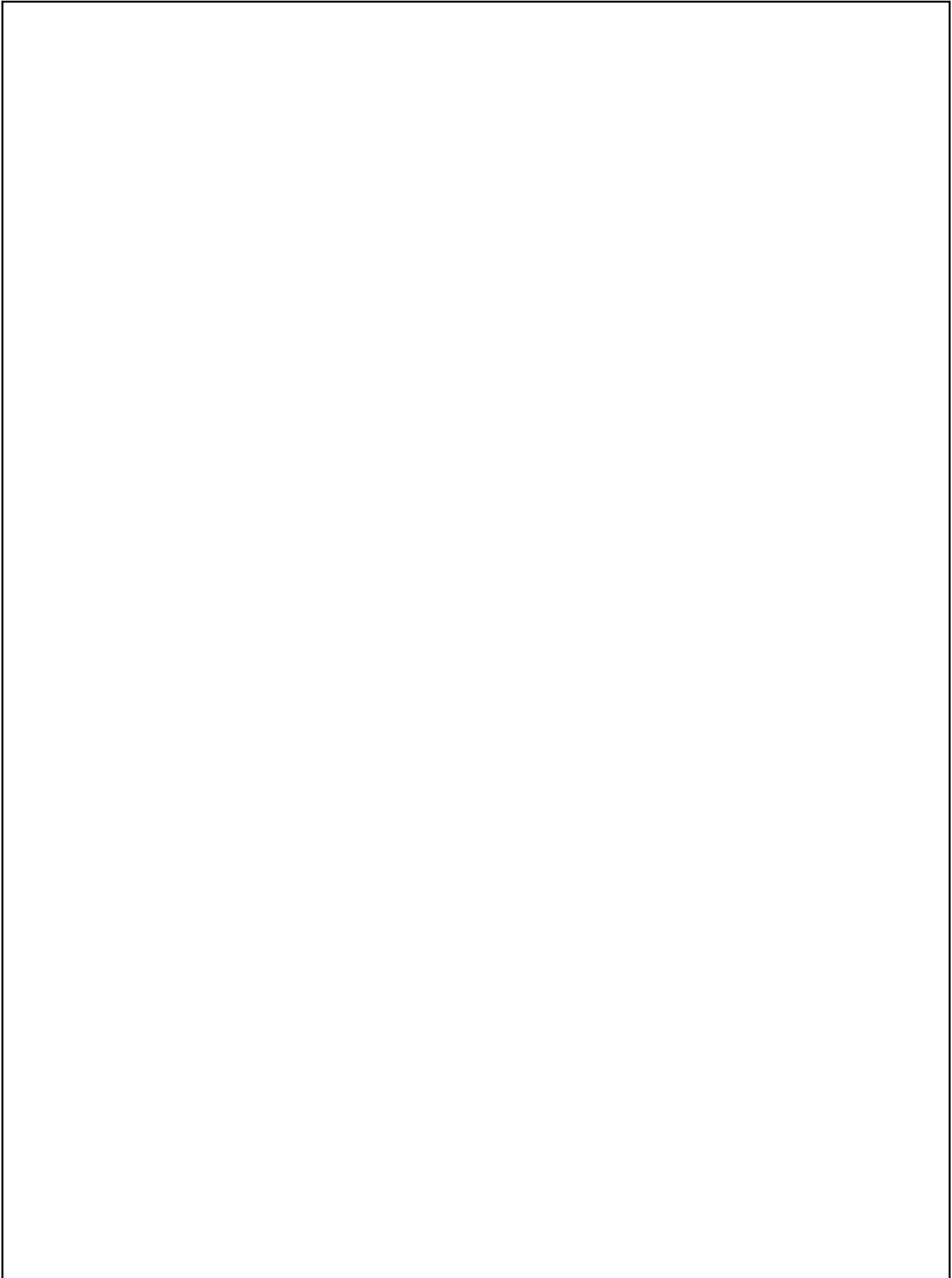

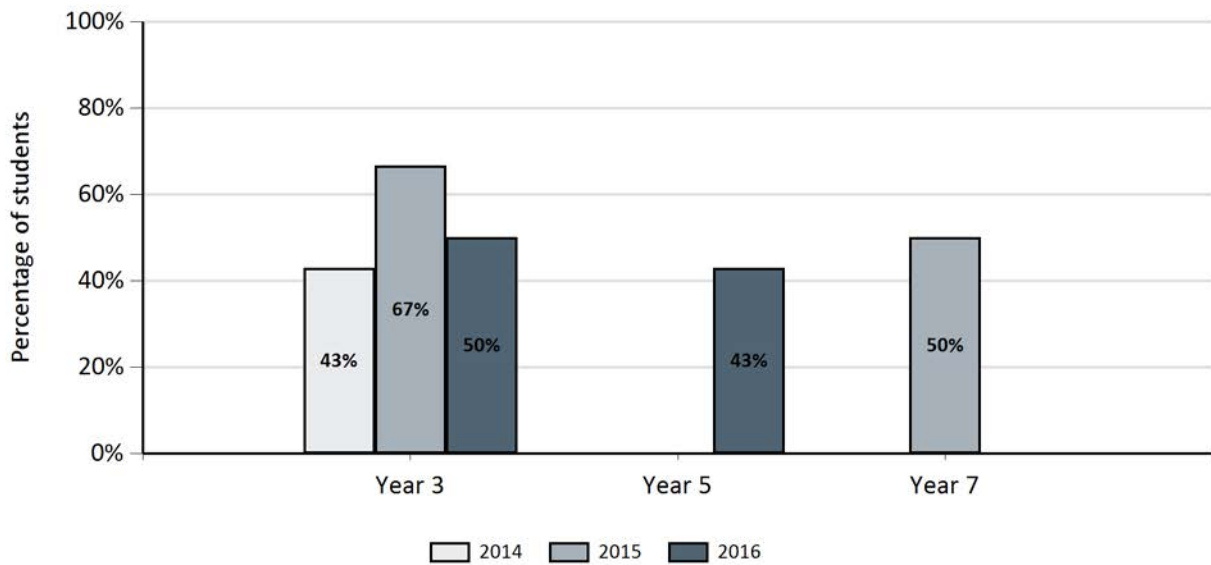

NAPLAN Proficiency

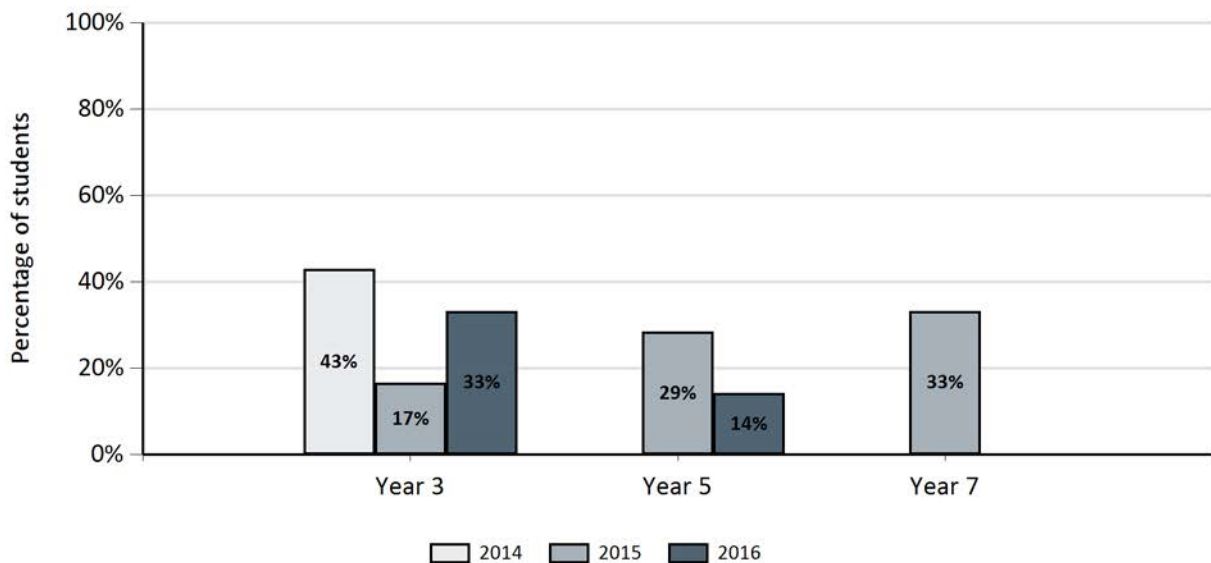

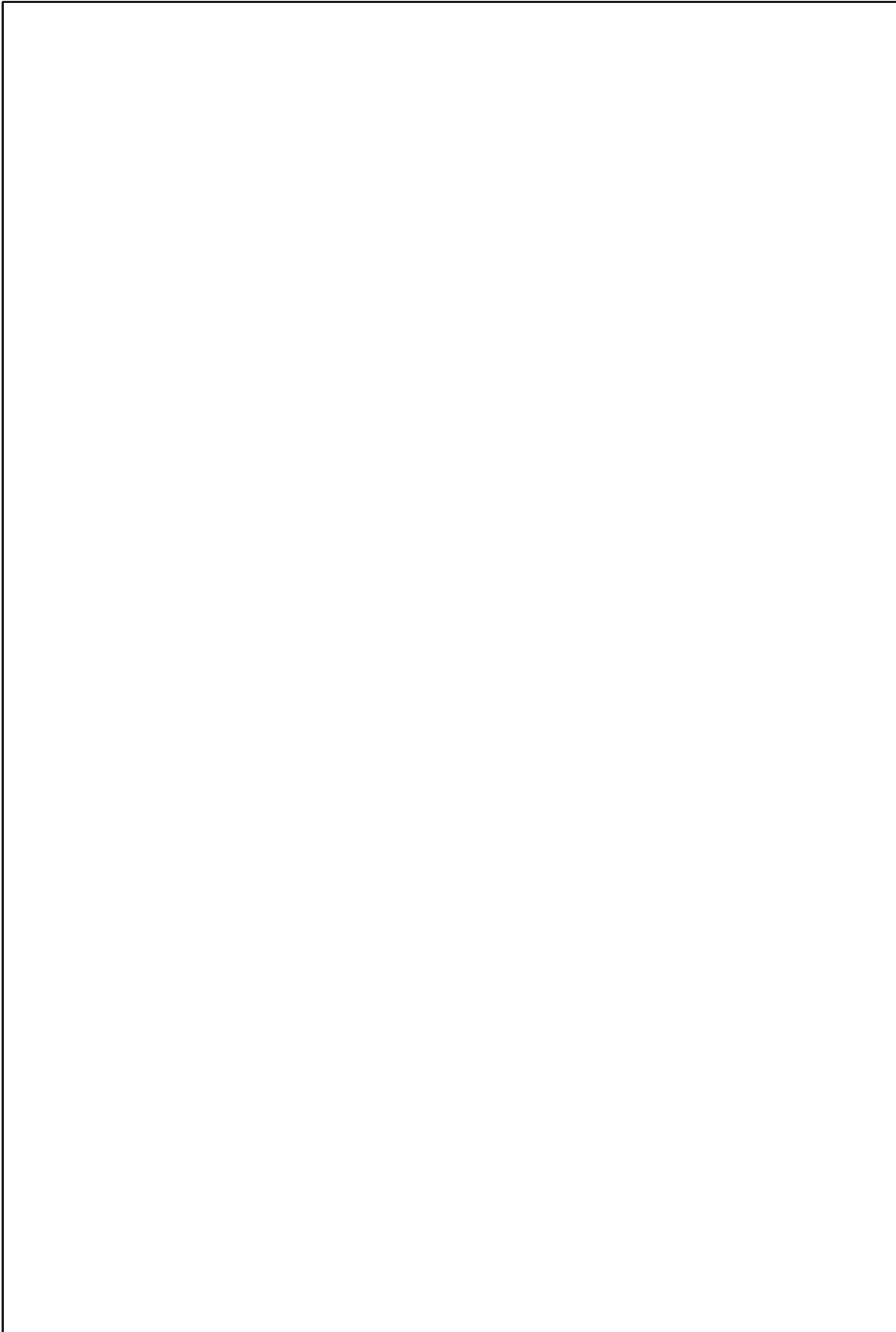
