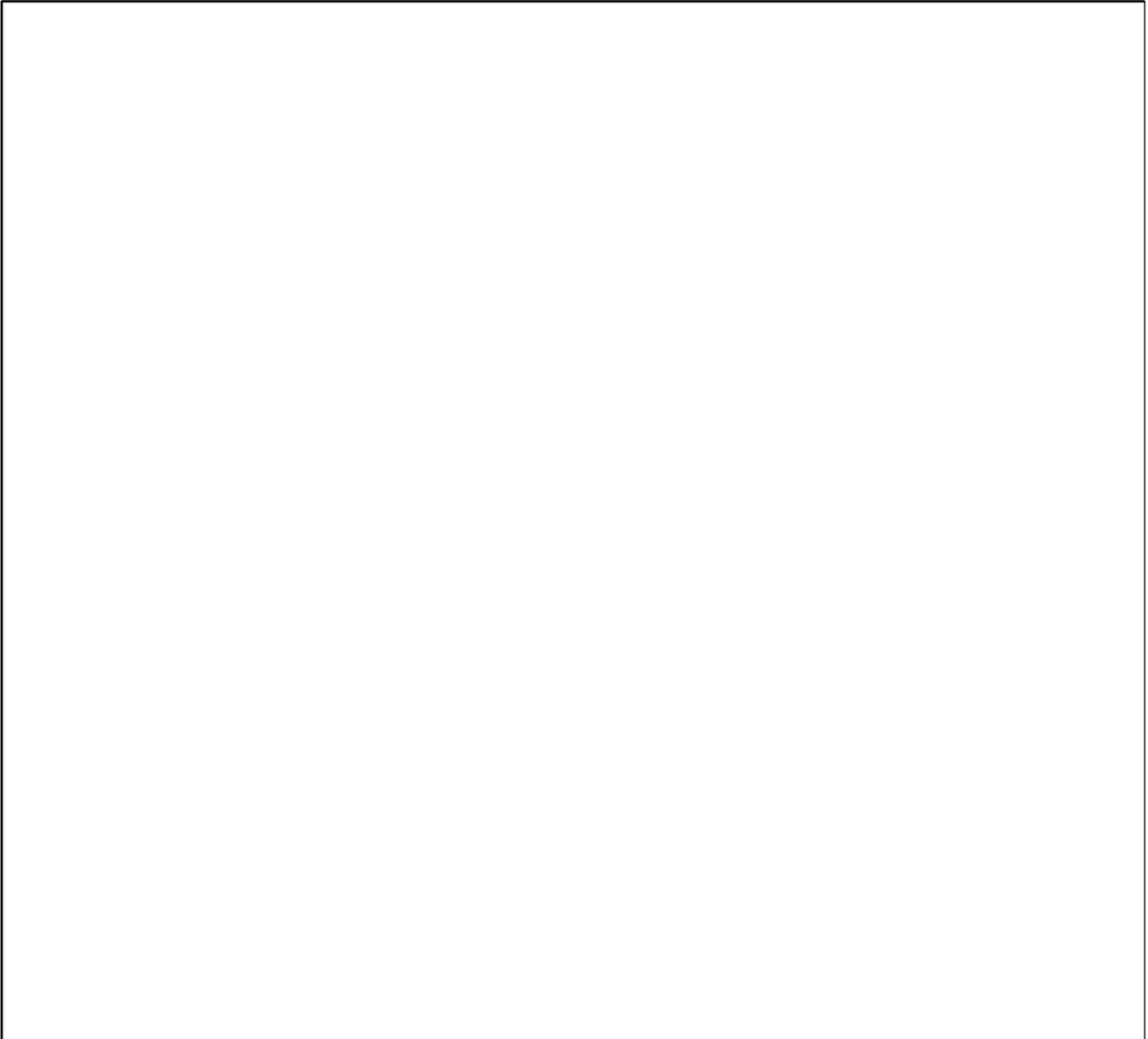



NAPLAN Proficiency


